BIDS MUST BE RETURNED IN SEALED ENVELOPES TO THE AFOREMENTIONED ADDRESS AND WILL BE ACCEPTED UNTIL 10:00 A.M. ON THURSDAY, JUNE 8, 2017.

BIDS WILL BE READ ALOUD IN THE BRADFORD COUNTY COMMISSION ROOM, LOCATED IN THE NORTH WING OF THE BRADFORD COUNTY COURTHOUSE ON THE AFOREMENTIONED DATE AND TIME.

THE BOARD OF COUNTY COMMISSIONERS OF BRADFORD COUNTY, FLORIDA RESERVES THE RIGHT TO ACCEPT OR REJECT ANY OR ALL BIDS, AWARD ALL OR PART OF THE BID, WAIVE ANY TECHNICALITY WITH REGARD TO THE BIDS, EXERCISE ITS LOCAL PREFERENCE ORDINANCE 2011-22 AND TO INTERPRET THE BID SPECIFICATIONS IN THE BEST INTEREST OF BRADFORD COUNTY.

BID INSTRUCTIONS

1. All bids shall be provided in a sealed envelope; shall be submitted not later than 10:00 A.M. on Thursday, June 8 2017; and shall be submitted to:

2. All bids shall be submitted in writing, on the “BID FORM” provided by Bradford County; shall include three copies of said form and shall be enclosed in a sealed envelope with “SEALED BID – HAULING OF MILLINGS” clearly marked on the front and back of said envelope.
3. Upon receipt of each envelope, Bradford County will record the date and time that the envelope was received.
4. Bids will not be accepted after the date and time indicated above.
5. Bids received by U.S. Mail, U.P.S., FedEx or other common carrier, will not be accepted if they are received after the date and time indicated above.
6. The Board of County Commissioners of Bradford County, Florida reserves the right to accept or reject any or all bids, regardless of the terms provided herein as well as to waive any or all defects in a bid submitted pursuant to these instructions.
7. The Board of County Commissioners of Bradford County, Florida further reserves the exclusive right to interpret these instructions to the best interest of Bradford County.
8. Any bid submitted pursuant to this Request for Bids must remain in effect for a period of twelve (12) months from the date of the award of the bid by the Board of County Commissioners of Bradford County, Florida. Bradford County further reserves the right and option to extend the bid amount for two (2) additional, twelve-month periods, if the successful bidder agrees to the same.
9. Any bidder who is affected adversely by the decision made by the Board of County Commissioners of Bradford County, Florida shall file with them a “Notice

of Protest”. Said notice shall be in writing and shall be made not less than 72 hours after the award of the bid. Failure to file this written protest shall constitute a waiver under Chapter 120, *Florida Statutes*, the Florida Administrative Procedures Act.

10. All bidders shall include with their bid (in triplicate) a completed Form W-9, Request for Taxpayer Identification Number and Certificate of Insurance.

PLEASE BE ADVISED OF THE FOLLOWING ADDITIONAL INFORMATION:

1. Bradford County may choose to obtain millings from various vendors. Any hauling of millings for Bradford County will require the picking-up of said millings from that vendor and delivery as follows:
2. Bradford County will require that millings be delivered to several locations within Bradford County:
 - A. Market Road - Health Department Site;
 - B. S.E. 8th Avenue – Keystone Site; and
 - C. Various Other Locations – for specific Road Projects.
3. Delivery of all millings ordered by Bradford County shall be made within 48 hours of said order, unless otherwise agreed upon in advance by Bradford County.
4. As is indicated on the attached “BID FORM”, each bidder will be required to provide information concerning the number of trucks that it proposes to use for Bradford County as well as the capacity of these trucks.
5. When completing the “BID FORM”, each bidder will also be required to provide their rate for transporting millings. This should be provided in the form of a “per-mile” figure. This figure will be the primary basis for the comparison between all the bidders’ rates. Please ensure that the “per-mile” figure includes ALL costs to be charged to Bradford County including wear-and-tear, staffing, etc.
6. With regard to fuel costs, Bradford County is aware that fuel costs may vary from time-to-time. For the purposes of completion of the “BID FORM” please indicate the fuel cost to be charged to Bradford County and any factors which may affect the fuel cost or which may require that the fuel cost be adjusted (surcharges, etc.).
