10.000 mills needed to fund the budget is greater than the rolled-back rate of 9.5178 by a margin of 5.0663%. 10.0000 mills is expected to generate ad-valorem tax revenue of approximately \$14,045,335.00; an increase from the prior fiscal-year of \$1,134,314.00, due to an increase in property values.

WHEREAS, on or about September 3, 2024, the Board of County Commissioners of Bradford County, Florida adopted the Tentative Millage Rate for Fiscal Year 2024-2025 following a public hearing as required by Section 200.065, *Florida Statutes*; and

WHEREAS, the Board of County Commissioners of Bradford County, Florida held a public hearing as required by Section 200.065, *Florida Statutes*; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Bradford County, Florida, as has been certified to the Board of County Commissioners by the Bradford County Property Appraiser, is \$1,404,533,463.00; and

WHEREAS, the Board of County Commissioners of Bradford County, Florida finds that the adoption of the tentative levying of ad valorem taxes as accomplished by adoption of this resolution is in the best interest of Bradford County, Florida and its citizens.

NOW THEREFORE be it resolved by the Board of County Commissioners of Bradford County, Florida as follows:

## Section 2. Purpose and Authority for Resolution.

This resolution is adopted for the purpose of adopting the tentative levying of ad valorem taxes for Fiscal-Year 2024-2025 and is adopted pursuant to the authority granted by Chapter 125, *Florida Statutes* and pursuant to the requirements of Chapter 200, *Florida Statutes*.

## Section 3. Adoption of Tentative Millage Rate.

The Board of County Commissioners of Bradford County, Florida adopts, for Fiscal-Year 2024-2025, as the tentative millage rate 10.000 mills, which is greater than the rolled-back rate of 9.5178 mills by a margin of 5.0663%.

## Section 4. Apportioned Amounts of Millage Rate.

The Board of County Commissioners of Bradford County, Florida, in accordance with the requirement of Section 200.011(2), *Florida Statutes*, hereby notifies the Clerk to the Board, the Auditor and the Bradford County Tax Collector of the following amounts to be apportioned to the different accounts out of the total taxes levied for all purposes:
