Mr. Sanders recommended that the Board authorize the Chairman to execute the forms on behalf of the Board. This precludes the Board from having to meet as a body to approve the final decisions and certifications.

School Board Member Erica Mains Reddish moved, seconded by Citizen Member Juliano, and CARRIED 4-0, to authorize the Chairman to execute the Decisions of the VAB to include Findings of Fact and Conclusions of Law and Certifications of the Value Adjustment Board.
