6. INTERIM COUNTY MANAGER REPORTS - WILL SEXTON

A. INFORMATIONAL REPORT/UPDATE – PUBLIC WORKS DEPARTMENT

Will Sexton recognized Public Works Director Jason Dodds to provide an informational report/update.

Mr. Dodds provided comments regarding the following updates:

- Purchase of a grapple truck from Mosquito Control State Funds.
- Operations of Solid Waste Collection Sites.
- Maintenance and housekeeping operations.
- Updates on the repairs at the Governor Charley E. Johns Conference Center.
- Sanitation efforts at all County Parks.
- Right-of-way trimming completed 122 miles.

Responding to Commissioner Spooner's inquiry regarding dumping during the holidays, Mr. Dodds indicated that no complaints were received.

Each Commissioner expressed appreciation to Mr. Dodds. Mr. Dodds presented closing comments and thanked everyone involved in the recent storm recovery efforts.

B. INFORMATIONAL REPORT/UPDATE – FIRE-RESCUE DEPARTMENT

Will Sexton recognized Fire Recue Director Allen Parrish to provide an information report/update.

Mr. Parrish provided comments regarding the following updates:

- Expressed appreciation of recognition awards.
- Commended all agencies that work together.
- Presented the Board with a **document** outlining Fire/Rescue information.
- Discussed challenges related to COVID-19 mitigation and future funding of Fire/Rescue.

Responding to Commissioner Spooner's inquiry, Mr. Parrish stated that the Moderna vaccine is what is being administered, but that he would need to verify with the Health Department. He confirmed that the Health Department has received additional help and has assigned additional appointment slots. Commissioner Spooner inquired about residency requirements. Mr. Parrish was unable to confirm; however, Chair Dougherty stated individuals do not have to be residents.

C. PROVIDE DIRECTION ON EXTENSION OF EMERGENCY COVID EMPLOYEE BENEFITS.

Mr. Sexton reported that Congress passed the Consolidated Appropriations Act, 2021 on December 27, 2020 that provides employers the option of extending the Emergency Paid Sick Leave Act and Emergency Family and Medical Leave Expansion Act benefits through March 31, 2021. Employees are only allowed to take advantage of this benefit one-time, up to 80 hours.

Will Sexton indicated that this benefit has not had a significant impact on the county's workforce or budget and therefore recommends that the Board elect to extend said benefit through March 31, 2021.

Commissioner Spooner MOVED to approve extension of emergency COVID employee benefits. Commissioner Riddick SECONDED the motion.

D. DISCUSSION OF DRAFT LEGISLATIVE AGENDA FOR 2021.

Mr. Sexton presented a list of legislative recommendations provided by each county commissioner for review and consideration. From the list, Mr. Sexton recommended at a minimum to include: 1) The \$1.19 million that was asked of the Legislature last year for enhancements to the State Road 100 Project, in conjunction with an existing \$2.3 million dollar Florida Jobs Growth Grant at the Airport; and 2) The Concerned Citizens Group request for funding for the RJE Center which the County sponsored last year. Both projects were vetoed by Governor DeSantis in the current budget.

After lengthy discussion among the Commissioners, Will Sexton suggested that staff create a narrative outlining the importance of all recommendations provided by the Board to include in Bradford County's Legislative Agenda for the Board to approve at their next meeting. Furthermore, he recommended that staff proceed with the submission of \$1.19 million for the State Road 100 Improvements Project and the Concerned Citizens Group RJE Improvements Project in order to make the January 19, 2021 appropriations application deadline.

Commissioner Spooner MOVED to approve the DEO Jobs Growth Grant and the Concerned Citizens for the legislative agenda suggestions and items to be discussed with the Legislative Delegation. Commissioner Andrews SECONDED the motion.

- Storm event during Christmas Eve and Christmas Day.
- On-going projects: 1) Distribution of sandbags; 2) Unmanned Aerial Vehicle Drones Program; 3) Emergency Operations appropriations in the amount of \$200,000.00 for planning and design.
