# C. BOARD APPROVAL OF COMMISSION MEETING DATES FOR CALENDAR YEAR 2020

As there was a conflict with an approved holiday, there was a consensus to cancel both the July 5 and September 6 Regular Meetings. ### D. SEEK DIRECTION FROM THE BOARD ON WHETHER TO APPROVE OR DENY A REQUEST MADE ON OCTOBER 15, 2020 BY TOMMY CROSBY ON BEHALF OF THE BRADFORD COUNTY FAIR ASSOCIATION FOR ADDITIONAL CARES FUNDING IN AN AMOUNT JUST UNDER \$50,000.00

Ms. Rhoden asked for direction from the Board <u>as outlined above</u>. She gave a brief update on the status of the CARES funding program for Bradford County.

At the request of Chair Dougherty and for the benefit of the new commissioners, Mr. Tommy Crosby presented <u>the request</u> again.

Chair Dougherty presented comments in favor of approving the request.

Mr. Crosby briefly reported on future plans for continued improvements and expansion of the facilities.

Commissioner Spooner presented comments regarding setting a precedence for other agencies or businesses in need of the same consideration.

Ms. Rhoden advised that there are critical deadlines to meet in order to finalize documentation to wrap up the CARES Program. Based on the critical deadlines, Ms. Rhoden did not recommend approving any other requests after the one currently before the Board.

Responding to inquiry by Commissioner Spooner regarding additional county needs that would qualify for CARES, Ms. Rhoden stated that there could be an opportunity between now and December 30<sup>th</sup> where needs may arise. However, there would be funding available made possible by the reimbursement of the public health and safety personnel salaries.

Vice-Chair Riddick presented comments supporting the request.
