WHEREAS, on or about September 5, 2023, the Board of County Commissioners of

Bradford County, Florida adopted the Tentative Millage Rate for Fiscal Year 2023-2024 following a public hearing as required by Section 200.065, *Florida Statutes*; and

WHEREAS, the Board of County Commissioners of Bradford County, Florida held a public hearing as required by Section 200.065, *Florida Statutes*; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Bradford County, Florida, as has been certified to the Board of County Commissioners by the Bradford County Property Appraiser, is \$1,291,102,087.00; and

WHEREAS, the Board of County Commissioners of Bradford County, Florida finds that the adoption of the tentative levying of ad valorem taxes as accomplished by adoption of this resolution is in the best interest of Bradford County, Florida and its citizens.

Section 1. Adoption and Incorporation of Recitals.

Section 2. Purpose and Authority for Resolution.

This resolution is adopted for the purpose of adopting the tentative levying of ad valorem taxes for Fiscal-Year 2023-2024 and is adopted pursuant to the authority granted by Chapter 125, *Florida Statutes* and pursuant to the requirements of Chapter 200, *Florida Statutes*.

Section 3. Adoption of Tentative Millage Rate.

The Board of County Commissioners of Bradford County, Florida adopts, for Fiscal-Year 2023-2024, as the tentative millage rate 10.000 mills, which is greater than the rolled-back rate of 9.7626 mills by a margin of 2.4317%.

Section 4. Apportioned Amounts of Millage Rate.

WHEREAS, the Board of County Commissioners of Bradford County enacted Ordinance 87-4 on September 9, 1987, establishing a countywide special assessment for the purpose of landfill and solid waste disposal; and

WHEREAS, Ordinance 87-4, Section 7C (2) grants authority to the Board of County Commissioners of Bradford County, "To adopt a resolution authorizing utilization of the method of collection of special assessments set forth in Section 197.0126, *Florida Statutes*, or other law of similar import, and incorporating a determination of the Annual Special Assessments to be imposed, levied, and assessed upon the owners of real property in the County;" and

WHEREAS, the division of property class was established by Ordinance 87-4 and amended by Ordinance 88-3; and

WHEREAS, an increase of 67% to all established property classes shall be applied; a chart providing the assessment by class is attached hereto as Appendix A

WHEREAS, A notice of Public Hearing was published on August 24, 2023, and August 31, 2023, in accordance with the requirements of Ordinance 87-4, Section 7C (2); a copy of which advertisement is attached hereto as Appendix B; and

WHEREAS, A letter regarding the notice was mailed to each property owner based on the 2023 tax rolls is attached hereto as Appendix C; and

WHEREAS, A public hearing was held on September 5, 2023, after 5:00 PM and all interested persons have been heard and considered, as required by Ordinance.

NOW THEREFORE be it resolved by the Board of County Commissioners of Bradford County, Florida as follows:
